**1. CALL OF MEETING TO ORDER**

There was a discussion about Village Insurance policy. McClone Insurance partners with the League of Municipalities Mutual Insurance. They offered to meet and give us a quote based on the insurance we already have. The quote they provided the Village is close to \$4000 cheaper than we pay now. The board asked if they would be willing to attend the next board meeting to discuss the quote we received further.

There was a discussion about possibly adding a chicken ordinance. The board is going to look over other municipalities' ordinances and discuss further later.

A motion was made by Sea Stahl and seconded by Matt Bonen to repair the swale by the burn pile at the sewer plant. Motion Carried. Unanimously. Jay Baumhardt abstained.
